Town of Jackson Town Board Meeting April 8, 2015

The Town Board of the Town of Jackson met on April 8, 2015 at 8:00 pm at the Town Hall for the monthly meeting.

Presentation by Cambridge Volunteer Fire Department

Cambridge Fire Department representatives, Nashua Alexander and Greg Danio, delivered a presentation explaining the process to establish a fire district and make it a separate entity from the village or towns. This fire district model, created by William Young of Guilderland, would be managed by a five-member, elected board of commissioners comprised of members from the community. Taxpayers would continue to pay a fire tax as part of their annual County/Town tax bill, however, the amount would no longer be determined by the Village or Towns, but rather the board of commissioners.

According to Mr. Alexander, the benefits of establishing a fire district would be to improve community input, stabilize the department's finances and decrease the number of tasks members of the department are involved with which can include fire protection, training, maintenance, finances, recruiting and fundraising.

The decision about whether or not the department becomes a fire district lies with the municipal boards (Village of Cambridge, Towns of Cambridge, Jackson and White Creek). Ideally, the fire department would like to implement this model by 2016. No decision has been made by Jackson's Town Board.

Highway – Supt. Carney offered the monthly highway report of the department's activities which included the ongoing leaky roof issues at the highway garage. Although he hasn't received official confirmation, he anticipates the Town will receive \$154,000 of CHIPs money for paving.

RESOLVED, to rescind Resolution #14 of 2015 and re-establish an account with Culligan to provide water to the highway garage.

Planning Board

At the March 10th meeting:

- The Steve & Melissa Skellie minor subdivision was re-approved due to a right-of-way that needed to be removed from the plat.
- Gary Pedersen, representing his mother, Irene Pedersen/Lake Lauderdale Campgrounds, Inc., met with the board to discuss the steps that must occur in order to move his project forward.

At the April 7th meeting:

- Boundary line adjustment was completed for Harold Gilbar on Allen Alley's Way.
- A resolution was passed extending the deadline 60 days for the Planning Board to reach a determination on the Washington County application so long as the County's designated agent signs an agreement supporting the resolution.

Historian – Town Historian, Sharon Dunn plans to attend the NYS Association of Public Historians conference. The conference will take place this month in Corning, New York.

Website – In the first quarter of this year, Jackson's official website has experienced a 30% increase in activity (hits) over 2014.

OLD BUSINESS

PrimeLink Internet – The Town received a quote from PrimeLink for fiber optic internet service. Unfortunately, the representative from PrimeLink was unable to attend the meeting so the topic will be tabled until next month so that Board can get their questions answered.

BE IT FURTHER REOLVED, that the Town of Jackson agrees to make its best effort to implement the Plan beginning in 2017 to 2019; and

BE IT FURTHER RESOLVED, that the Town of Jackson Town Board authorizes their Town Supervisor to certify the Government Efficiency Plan.

Clean-up of Town Hall – A date will be set at the next Town Board meeting to clean-up the Town Hall before the June 17th visit by the Country Schoolhouse Association of America.
