PUBLIC HEARING – MICHAEL & WENDY STEINDL

Wendy Steindl was present with an updated survey map of their property located at 3502 State Route 22 (parcel #216.-3-30/8.4 acres). They wish to create two new lots from their 8.4 acre parcel. Lot 1 will be 2.77 acres; lot 2 will be 3.10 acres and lot 3 will be the remaining lands. In addition, they would like to make a boundary line adjustment between the north end of that parcel (remaining lands) and their other parcel (#216.-3-13/17.25 acres) to ensure that the septic on the existing residence lies within the parcel's boundary lines.

Adjacent neighbors Jean & Norma Skellie were present to ask about the plans for the new lots and to review the map. A **motion** was made by Tully, seconded by Nolan to close the public hearing at 7:49 pm. Motion carried in favor 6-0.

7:50 PM PUBLIC HEARING – CHAPIN AIR PARK, LLC

Dean and Evelyn Chapin were present with an updated survey map of their property located along State Route 22 (parcel ID 248.-1-23.1/140.3 acres). They propose to subdivide 73.07 acres located between the eastside of State Route 22 and the railroad that abuts the airport portion of the parcel. Since the parcel also extends west across State Route 22, this minor subdivision would create a second new lot of 19.97 acres. If the subdivision is approved, the Chapins plan to sell the 73.07 acres to a local farmer and anticipates that it will continue as agricultural land. They do plan to retain the smaller parcel of 19.97 acres on the west side of State Route 22 as well as the air park.

Adjacent neighbors Peter Netusil and Teresa McMahon were present with questions about the air park portion that were determined to be questions for the federal government. A **motion** was made by Tully, seconded by Gordon to close the public hearing at 8:05 pm. Motion carried in favor 6-0.

PLANNING QUESTIONNAIRE

The board discussed the planning questionnaire results. The board agreed that the respondents frequently commented that they want to see the character of the town preserved and that the town needs some additional regulations. Headwell commented that current laws have not been enforced in Jackson (i.e. junkyard ordinance) so how would new, land-use regulations be enforced. Mahoney stated that, in general, the public is not aware that the neither Planning Board nor Town Board has any power to stop potentially undesirable projects from being established in Jackson. Although the board doesn't want to deter new business from coming to Jackson, often reputable businesses appreciate having some guidelines where they wish to locate their business.

The lake/river areas were also discussed. One idea would be to ask those residents on the lake and/or river about what restrictions and/or permissions they would like to have created.

Chairman Hanf will make a report to the Town Board.
