## **REPORTS**

**Highway** – Supt. Carney reported on the daily tasks of the highway department.

**Planning Board** – Chairman Hanf reported that he had spoken with the Department of State regarding the use of a conditional approval when considering the Washington County Transfer Station project. A representative from Washington County plans to attend the January  $6^{th}$  meeting where the SEQR will be completed. We anticipate Earth Waste Systems sending a representative who can speak about the environmental impacts relevant to the subdivision.

**Fuel Bids** – Fuel bids were received from G.A. Bove and Main-Care Energy. Although G.A. Bove's prices were slightly lower, the Highway Supt. preferred continuing with Main-Care Energy citing their multiple years of consistent and reliable service.
