## MINUTES

A **motion** was made by Gordon, seconded by Nolan to approve the January 5<sup>th</sup> minutes a few corrections. Motion carried in favor, 6-0 (Mahoney abstaining).

# **DON & LISA OTEY**

Lisa Otey was present with the 1995 map of their four parcels, formerly owned by Tracy Materials, along Skellie and Carney-Cassidy Roads. The map identifies four parcels each with four tax map numbers and four tax bills. However, Lot #3 (tax map #215.-3-20 / 25.14 acres and #215.-3-20.2 / 37.07 acres) are not adjacent but described in the deed has one lot comprised of two non-contiguous portions. Mrs. Otey would like to subdivide the northern portion of Lot #3 for the purpose of selling it. Mahoney suggested rather than identifying the northern portion as "remaining lands" to give it a lot number.

In addition, Mrs. Otey would also like to have a boundary line adjustment between parcels 215.-3-20.4 and 215.-3-20.5. Her proposed line for the boundary line adjustment goes beyond the 100 ft. limit thus creating a major subdivision. The Planning Board offered suggestions as to how a boundary line adjustment could be achieved.

The Board classified this project as a minor subdivision with a boundary line adjustment. The Board completed the SEQR.

A **motion** was made by Gordon, seconded by Mahoney to classify the project an unlisted action. Motion carried in favor 7-0.
