# **REPORTS**

**Highway** – Due to ongoing weather challenges, Supt. Carney was unable to attend the meeting. Supervisor Brown did mention that Supt. Carney was looking at a used grader for the Town.

#### **Planning Board**

- Boundary line adjustments (BLA) were approved for Mark N. Kenyon and adjacent property owner Bob Mungas. As part of their BLAs, these neighbors plan to convey land to the other neighbor.
- A major subdivision was reviewed for Skellkill Farms and a minor subdivision was reviewed for Steve and Melissa Skellie. The SEQRs were completed for both projects and public hearings will be held in March.
- An updated application, SEQR, and map were provided to the Planning Board for the Washington County Transfer Station minor subdivision project. A public hearing will be held in March.

**Jackson's Bi-Centennial** – The Town of Jackson will celebrate its bi-centennial this year. The Board decided the best time for a celebration would be the summer picnic. Supervisor Brown will contact the County for a date.

## **NEW BUSINESS**

Acknowledgments – A heartfelt thank you note was received from Roger Meyer for the flowers sent to honor his wife's passing. Also, [Councilman Nolan] commented about the passing of the Francis Ackley who served the Town for many years as a Town Board member and Justice.

**Medical Marijuana Project** – Washington County Ag Park owner/resident Ted Berndt and resident Steve Lulla were present to seek support from the Town Board regarding their efforts to be selected as one of five registered sites in the State of New York to grow medical marijuana and have four dispensaries (retail outlets) under the Compassionate Care Act. Applications are merit-based and if selected, could result in 20-30 jobs for the Town of Jackson. Chosen facilities are highly regulated with several layers of security. They expect to host open houses to help educate the public.

#### **RESOLUTION NO. 12-15**

**RESOLVED,** that the Town Board of the Town of Jackson unanimously supports the Compassionate Relief Center of New York, Inc. in their efforts to be selected as a registered site to cultivate and process medical cannabis at the Washington County Ag Park located at 15 Plains Road in the Town of Jackson, Washington County, New York; and, **BE IT FURTHER RESOLVED,** that Supervisor Brown will write a letter **[to Dr. Howard Zucker, Commissioner of the New York State Department of Health as well as Stephen Lulla and Ted Berndt, co-CEOs of]** Compassionate Relief Center of New York, Inc. expressing **[the Town of]** Jackson's support **[of this application and project]**.
