1:00 PM PUBLIC HEARING – LOCAL LAW #1 OF 2017

Supervisor Skellie opened the public hearing at 1:00 pm for Local Law #1 of 2017 to opt-out of Section 487 of the NYS Real Property Tax Law concerning tax exemptions for qualified solar, wind power and farm waste energy systems.

Ted Berndt, owner of the Ag Park on Plains Road, requested that the Board rescind the moratorium extension as well as table the law to opt-out of the solar exemption. Mr. Berndt is in favor of the PILOT program where the Town negotiates with owners of large solar projects to determine a lower taxable assessment. He also questioned why the Town Board included methane digesters in the opt-out law.

John Pedersen question how solar arrays would be assessed.

The public hearing closed at 1:19 pm.

REPORTS

Highway – The Highway Superintendent shared the department's activities in January which focused primarily on snowplowing, sanding, equipment maintenance and cold patching. He also shared concerns about the cost to replace a culvert on Carney-Cassidy Road (\$11,300) and Murphy's Lane (\$7,250). These are just a few examples of large culverts that need replacing. Supt. Carney is reaching out to *Culvert NY* to see if they might provide assistance.

The fourth bridge on Murray Hollow Road, just past Dave Jeskie's property, must be replaced within the next 12 months. The estimated cost is \$100,000. The other four bridges on that road will also need replacing over the next few years.

The Highway Garage was recently inspected. The department is required to install a back door (west side of building) for evacuation purposes.

Planning Board -

• Harold Gilbar (Hedges Lake, Inc.) presented his updated map to subdivide one section of the nine-part, non-contiguous, waterfront parcel (#231.59-3-46). A public hearing is scheduled on March 7th.
