RESOLUTION NO. 16-17

February & March Town Board Meetings

RESOLVED, that the Town Board will move the February & March Town Board meetings to the second Wednesday of each month (February 8th and March 8th) starting at 1:00 pm in order to accommodate Town Board members' schedule conflicts.

Lewis Waite Farm – Supervisor Skellie has been asked by both the Agricultural Stewardship Association and Lewis Waite Farm to write a letter in support for the Forever Farms Federal Grant program. The letter will state that this effort will be an asset to the township. There were no objections from the Board.

SITE PLAN REVIEW DRAFT (SPR)

Chairman Hanf opened the site plan discussion by sharing the most recent changes to the plan which focus on flood management and Local Law #1 of 1992. There were also questions about reviewing residential projects (single-, two-family and mobile homes) where the owner wants to increase a square footage by more than 25% of its current size. The Board asked for that to be removed from the plan.

They also discussed a couple of examples of how the plan would be put into action depending on the project. The Board agreed to schedule a public hearing at the February 8th Town Board meeting after revisions have been made to the document.

RESOLUTION NO. 17-16 Hold Public Hearing for LL #1 of 2017
