LOCAL LAW #1 OF 2016 - MORATORIUM ON CERTAIN SOLAR USES

A number of people were present to comment on Local Law #1 of 2016 – Moratorium on Certain Solar Uses.

Valerie Reagan suggested that the following bolded words be added to Part D, three lines from the bottom of the paragraph: "...to affix to residential buildings for their use, small businesses and farms or municipal or educational buildings..."

John Pedersen agreed with Ms. Reagan's comments and added that the correct term for solar farms is solar arrays.

Ted Berndt requested that the Town Board vote down the moratorium so that he can continue with his business plans to install solar arrays without competition from the Village of Cambridge.

Carman Bogle shared that the Village of Cambridge is hoping to place solar arrays on the old landfill property which is owned by the Village but lies in the Town of Jackson. She has asked that the moratorium be delayed three months. Public hearing closed at 8:35 pm.

TY MCLENITHAN – Ty McLenithan was present to comment about dog issues where he lives on Johnson Road. A few weeks ago his dog was attacked by another dog housed at the apartments at 4 Johnson Road (Mr. McLenithan had his veterinary bill with him.) The Dog Warden was called twice, but didn't show. Just a few days prior to the Town Board meeting, the Dog Warden was called by a different resident at 4 Johnson Road stating that Mr. McLenithan's dog was wandering at the apartments. The Dog Warden came and stated that tickets will be issued to Mr. McLenithan for not keeping his dog on a leash. While Mr. McLenithan understands that his dog should not be freely wandering, he's angry that the Dog Warden didn't respond to his calls after his dog was attacked. In addition, any dogs located at 4 Johnson Road are not licensed. No action was taken by the Board.

Supervisor Skellie held a meeting with the Town's insurance agent to better understand our policy and the increase.

WHEREAS, Washington County has proposed a feasibility study for the project titled Shared Regional Highway Operation Centers; and

WHEREAS, the grant will fund the development of a plan to optimize the delivery of highway and maintenance services and identify ways to reduce costs. The project will identify ways to improve efficiency, identify shared equipment possibilities, and reduce overall administrative expenses, while reducing taxpayer burden; and

WHEREAS, the State of New York has made Local Government Efficiency Grants available through the Department of State to promote inter-municipal collaboration; and

NOW THEREFORE IT BE RESOLVED that we, the Town of Jackson, support and will commit to the Washington County Shared Regional Highway Operation Centers Feasibility Study by the involvement of our personnel and in-kind contributions.

Information:

- Former Highway Superintendent and longtime Jackson resident, Clifford Rowland passed away on July 4th. A card was signed and will be mailed to his wife. In addition, the Town Board and a few others made a donation to the Salem Fire Department in his memory.
- Carman Bogle reminded everyone that the Village of Cambridge and the Cambridge Fire Department's 150th Anniversary celebration is scheduled on July 16th. All are welcome!
- Mark Mahoney again offered to construct something to display the American flag outside the Town Hall. After some discussion, it was decided that a pole could be erected on which to raise the flag. Sharon Dunn thought that the DAR might provide either the solar light or the money to purchase one.

County Update - Supervisor Skellie shared that the County's annual tax auction in June went very well. In Jackson, there was only one property expected to be sold, however, the taxes were paid just prior to the auction.
