FLORENCE CARNEY ESTATE

Leilani and Raymond Rasmussen were present along with surveyor, Peter Bell to present the survey map for the Florence Carney Estate where they wish to create two, new lots from the 280.54 acre parcel (tax map #231.-1-6).

Parcel one of approx. 63 acres will be all lands located east/southeast of Reafield Farm Road and would include the existing residence, barns and a camp. This was the former home of Alan "Bud" Carney. The Board approved a variance at the October 4, 2016 meeting to allow Reafield Farm Road to be a definitive boundary of this parcel as no other boundary lines will change.

Parcel two comprised of 20.13 acres will be located in the south central portion of the parcel with Reafield Farm Road as the east boundary and Carney-Cassidy Road as the west boundary. This parcel includes Florence Carney's homestead and a few barns.

The remaining lands of 197.41 acres will include the dairy farm and remaining crop lands. All parcels are expected to remain within the family.

The Board completed the SEQR.

A **motion** was made by Gordon, seconded by Record to classify the project an unlisted action. Motion carried in favor 5-0.
