RESOLVED, that the Town of Jackson will continue to offer health insurance through CDPHP.

RESOLUTION NO. 79-14

Health Insurance Contribution

Resolution by Councilman Rouse Seconded by Councilman Nolan And passed said Board, 4-1 with Supervisor Brown voting against

RESOLVED, that in 2015 the health insurance employee contribution for Town Board members will increase to 60% of the premium.

Councilman Nolan commented that he is concerned about the methods used to reduce the budget including adjusting the health insurance buyout policy. He believes it will create problems in the future and plans to vote against adopting the 2015 Budget.

Budget Officer Donna Nolan stated that while amendments are being made to the health insurance policy, a statement should be included that requires any employee using the health insurance buyout option must show proof of health insurance through another entity. The Town Supervisor, the Budget Officer and Town Clerk will work together before the December meeting to amend the wording of the health insurance policy.

RESOLUTION NO. 80-14

Adoption of 2015 Budget

RESOLVED, to adopt the 2015 budget as amended which includes a 3.3% increase which is still within the allowable 2% tax cap.

After the budget passed, Supervisor commented that workman's compensation rate will be decreasing and the tax assessment will be increasing thereby reducing the tax increase to just under 3%.

REPORTS

Highway – The wood stove at the highway garage continues to need repairs. The staff will finish welding it this week. There was a lengthy discussion about replacing the 24-year-old loader or one of the trucks. Supt. Carney will continue to search for high-quality, used equipment.

Planning Board – No report as the meeting will be November 17th.

OLD BUSINESS

Town Hall Building Maintenance – The Town Hall maintenance project is almost complete with only a few details still to complete.

Outside Lighting at Town Hall – Exterior lighting at the Town Hall the night of the Election was not sufficient. After some discussion, it was decided that a new motion-censored light will be added to the back entrance of the Town Hall. In addition, the motion light near the handicapped parking area will be replaced as well as the bulb on the post at the north end of the parking lot.

Bond Anticipation Note (BAN) – Town Atty. D. Alan Wrigley has prepared a BAN so that the Town can borrow \$10,000 at a rate of 2% for repairs to the Town Highway Garage and the Town Hall. See attachment at end of these meeting minutes for **RESOLUTION NO. 81-14.**
