Replacement of Audit Committee Member

RESOLVED, to appoint Councilman Rea to the 2016 Audit Committee to replace Councilman Rich.

Town Hall Flag – The Town has received \$350 in donations towards erecting a flag pole at the Town Hall. Mark Mahoney received one quote for a flag pole that was quite expensive. The Board suggested Mr. Mahoney contact a business in Gansevoort for a quote. The Town Clerk will send thank you notes to the donors.

Carney-Cassidy Road Issues – The Town Clerk received a lengthy email from the same Carney-Cassidy Road resident who has sent several emails during the past couple of years. He continues to push the Town to improve the road's width and drainage. The letter is on file with these minutes.

The Town Clerk contacted Henry Van Den Heever, Senior Risk Control Specialist at NYMIR (Town's insurance company) to ask about liability. Understanding that the road has been inspected by the Town Highway Supt., the Town Supervisor (previous and current) as well as the County Highway Supt., and all agree that the current road condition is acceptable, Mr. Van Den Heever believes *the only obligation the town has at this juncture is to ensure that the resident complaint has been properly recorded in accordance with the town's defect (prior) notice law.* He also wrote, *You also mentioned that the*

resident has complained that the road may be too narrow in the vicinity of his residence. If the road has been in use at the current width for over 20 years, then the town has no legal obligation to widen it.

A response letter will be written and send to the resident.

Appointment Board of Assessment Review

2017 Health Insurance

RESOLVED, that the Town of Jackson will continue with the current health insurance providers in 2017 which includes MVP (at a 1% increase) and CDPHP Medicare Advantage (at a 12% increase).

Sandra Vincent

• Sandra Vincent shared that she believes some headstones at the Revolutionary Cemetery located on Wellbrock's property have been damaged. Councilman Rouse commented that there have been damaged headstones at that location for years. Since the cemetery is located on private property, the Town has no jurisdiction. It was suggested that Ms. Vincent contact

the Hoosick Falls police because they have been dealing with cemetery damage in recent weeks and perhaps there's a connection.

• She was also seeking a location to display a sculpture she hopes to create in honor of Bill McMorris, Jr. Although this is not a Town matter, Councilman Rea offered to locate the sculpture on the knoll adjacent to the McMorris property where he owns land.
