# **REPORTS**

**Highway** – Supt. Carney passed out copies of Town Highway Law 205 (Highways abandoned) for the Board's review. Documentation was found that the Town Board passed a resolution in December 2006 abandoning both Bells and Wrights Lanes. However, the wording of the resolution needs to be slightly modified for it to be official.

**RESOLUTION NO. 65-15** 

Abandon Bells & Wrights Lanes

**WHEREAS**, Bells Lane and Wrights Lane have not been maintained or used as a town highway for more than six (6) years,

**NOW, THEREFORE BE IT RESOLVED,** that Bells Lane and Wrights Lane be removed from the Town of Jackson inventory of roads.

## Planning Board -

- Despite not having a formal application from Lake Lauderdale Campgrounds, Inc. (LLCG) / Irene Pedersen, the August 11<sup>th</sup> meeting was an informational session for neighboring summer residents to learn about the project before leaving for the summer.
- At the September 1<sup>st</sup> meeting, the Planning Board approved another extension for the Washington County Transfer Station project for which they can approve or deny the application until the December meeting subject to the County signing the agreement by September 14, 2015.

# **OLD BUSINESS**

**Jackson's Bi-Centennial/Summer Picnic** – Approx. 175 people attended Jackson's Bi-Centennial and Town-wide Picnic celebration on August 7<sup>th</sup>.

**WHEREAS**, Lewis Steele chaired the 2015 Town of Jackson Bi-Centennial Town-wide Picnic Celebration coordinating promotional efforts, seeking donations to pay for a local band and cospearheading the creation of a bi-centennial t-shirt; and,

**WHEREAS**, Lisa Falconer-Otey once again utilized her creative skills to update the promotional poster and design a bi-centennial t-shirt; and

**WHEREAS**, John Pedersen assisted with the lettering for the sign at the Town Hall as well as a sign highlighting the donors who contributed to the cost of the band; and

**NOW, THEREFORE BE IT RESOLVED,** that the Town Board of the Town of Jackson wishes thank each of these town residents for their efforts to make the Town of Jackson's Bi-Centennial Town-wide Picnic Celebration a huge success.

**2016 Budget** – Village of Cambridge has submitted a three-year fire contract for the following amounts:

- 2016 \$29,433.00 (1% increase)
- 2017 \$29,727.00 (1% increase)
- 2018 \$30,322.00 (2% increase)

The Town Board will make a decision at a later date. There was also a brief discussion about selling the older grader in the spring of 2016.

**Hedges Lake** – No update

**Town Hall Flag** – Mark Mahoney has taken the flag that hangs outside of the Town Hall to make adjustments to it so that it won't ravel up due to the wind. Mr. Mahoney also shared that John Sheaff stated that the Sons of the American Revolution might be willing to donate \$100 toward creating a staff to hang the flag above the schoolhouse as it once was 60+ years ago. The Board liked the idea.
