**RESOLUTION NO. 37-14**

# **REPORTS**

**Highway Report** – Along with their regular duties the highway department also completed MSHA training and installed three new culverts. Supt. Carney discussed the roads he hopes to work on this summer.

#### **RESOLUTION NO. 40-14**

Agreement to spend highway funds

Resolution by Councilman Nolan Seconded by Councilman Rich And passed by all board members, 5-0

**RESOLVED**, that pursuant to the provisions of Section 284 of the Highway Law, the Jackson Town Board agrees that moneys levied and collected for the repair and improvement of highways and received from the State for the repair and improvement of highways, shall be expended as follows:

General Repairs: The sum of no more than \$181,000.00 may be expended for general repairs upon 57.75 miles of town highways, including sluices, culverts and bridges having a span of less than five feet and boardwalks or the renewals thereof.

Improvements: The following sum shall be set aside to be expended for the improvement of the following town highway:

(a) On the road, commencing at Cambridge-Battenville / Old Cambridge Road intersection and leading to the distance of 1.5 miles, north to Center Falls Road intersection. There shall be expended not over the sum of \$128,473.13.

Type: 6

Thickness: 1.5 inches
Width of traveled surface: 19 feet
Sub base: pavement

(b) On the road commencing at Colfax Mountain Road / Fire Tower intersection and leading to a distance of approximately 6,175 feet south on Colfax Road. There shall be expended not over the sum of \$17,521.54.

Type: 1A chip seal

Thickness: n/a
Width of traveled surface: 18 feet
Sub base: binder

(c) On the road commencing at Kenyon Hill Road / Colfax Mountain Road intersection and leading west a distance of approximately one-quarter mile. There shall be expended not over the sum of \$6,005.33.

Type: 1A chip seal

Thickness n/a
Width of traveled surface: 18 feet
Sub base: binder

## **Planning Board**

- The Fowler minor subdivision was approved on June 3<sup>rd</sup>.
- Brian & Jeannette Dunn submitted an application for a minor subdivision on Kenyon Hill Road. A public hearing will be held in July.
- Chairman Hanf received questions from a local attorney about a client's possible purchase of Hedges Lake, Inc. The Planning Board Clerk will review the file and talk with the attorney.
- The Planning Board is still receiving feedback about the draft comprehensive plan (CP). A lengthy discussion about the CP occurred after the Planning Board report.

**Website** – The Town Clerk will be meeting the website developer on June 5<sup>th</sup> to receive training and to review the missing items and links.

## **OLD BUSINESS**

**2014 Jackson Town Picnic** – Rather than have a "Chairperson" for the picnic, it will be committee overseeing the details. Lewis Steele and Lisa Otey will update the poster; Carol Rich will coordinate the supplies and the Town Clerk will put news releases in the newspaper.

**Town Hall** – The Board discussed the maintenance that needs to be completed on the Town Hall including:

- Cabling the building;
- Possibly removing the concrete entrance steps;
- Replacing the wooden strips around the old doors and windows facing the north; and
- Painting the building.

Due to the extensive work that needs to be done, the Board decided to hold a budget meeting on Tuesday, June 17<sup>th</sup> at 8 pm.
