Highway - The highway department:

- plowed/sanded eight times in March;
- serviced the grader;
- removed trees; and,
- completed a brake job on the 2007 truck.

Supt. Carney has connected with *Culvert NY* to seek funding for bridge replacement on Murray Hollow Road. Applications are due in the summer with selection in late fall. If accepted, the Town would not be the entity to replace the bridge. The funding would provide for design, engineers, staff and inspections. The liability would fall on the company that replaces the bridge. The Town of Arlington has been contacted to determine the number of parcels that could be impacted beyond the NYS line. In addition, Jackson will request a letter of support from Arlington to accompany the application. The Board agreed that the Highway Superintendent should proceed with completing an application.

Planning Board -

• Harold Gilbar (Hedges Lake, Inc.) was present with a sketch plan to complete five boundary line adjustments of the nine-part, non-contiguous, waterfront parcel (#231.59-3-46).

Site Plan Review Law – Following the March public hearings, Supervisor Skellie, Chairman Hanf and Mark Mahoney met with Town Attorney Alan Wrigley to review the changes Mr. Wrigley suggested. While most of Mr. Wrigley's changes were incorporated, a couple of items are being revised.

Flag Pole Update – The flag pole was picked up this winter. Brian Nilsen will make brackets for it. The Board hopes that the project will be complete before Flag Day so we can notify the donors with the celebratory news.

Cambridge-Battenville Road dust issue – Once again, the resident on Cambridge-Battenville Road who has annually requested that the highway department control the dust on her road, called to ask about a "spring season" road treatment that she thought she heard might be a proactive step for addressing this problem. In her plea, she stated that she is tired of asking for this service each year and commented that if the Town does not follow through, she might take legal action. The Board said they would leave the decision to the Highway Superintendent.

Committee for Town Board Compensation – Councilman Nolan and Rea have discussed the current and future compensation for Town Board members. After reviewing research of what other Washington County Towns offer, they suggested that any newly elected board members receive \$1,500 annually with no option for health insurance while incumbents are grandfathered to receive \$600 annually plus the health insurance option. No further action was taken.

NEW BUSINESS

Town Picnic – Councilman Rich will contact Lewis Steele to see if he will again oversee the updating and distribution of the picnic posters.

Town Hall Roof Issues – The Town Hall roof has missing slate pieces. Shelly Clous evaluated the roof and said that about 17 slates need repair. In addition, screens need to be installed near the soffits as critters are entering the attic space and chewing the insulation.

RESOLVED to hire Shelly and Mikel Clous to complete the Town Hall roof repairs and screening for an estimated \$1,300.

Area Code Overlay – The Town Clerk received information on the Area Code Overlay that has already begun in the 518 area code. The information has been posted to the home page of the Town's website.

County Update – NYMIR, the insurance company for Washington County as well as most townships, recently determined that several municipalities have been overcharge for premiums on their fleet. NYMIR met with several Supervisors to explain how it happened. Refunds have been issued (for up to five years back) to those who have reviewed their policies. Supervisor Skellie and Supt. Carney will review Jackson's policy. The Town renews its policy annually in early summer.
