- The department was busy with storm clean-up. The 2005 truck sustained damage while dumping logs. He is working with a few businesses to find a replacement box.
- The two tandem trucks have new tires and are ready for winter.
- The final bids for the seven items placed on Auctions International totaled \$8,740.00.

- The Johnson Road water issues continue. A few people were present to ask about the next steps. Supt. Carney said the County "engineers" have taken measurements and are expected to develop a plan. When asked about a timeline, Supt. Carney could not be specific. However, once a plan is devised, Supt. Carney plans to hold a meeting for all of the residents on Johnson Road who are impacted by the situation.

Planning Board – Due to the election, the Planning Board meeting was postponed to November 14th. However, as an update Mike Morgan believes he has resolved any concerns about pin-placement between the Whelan and Gilbar waterfront properties along Hedges Lake.

Cold War Veteran Exemption – The ten-year limitation on Local Law #1 of 2008 - Cold War Veteran exemption concludes this year. The Town Board has the option to continue to offer the exemption. Laura Chadwick of the Washington County Real Property Tax Services sent a sample amended law to extend the exemption.

RESOLVED to hold a public hearing on Local Law #3 of 2017 – extension of Cold War Veteran Exemption beyond the ten-year limitation - on Wednesday, December 6, 2017 following the public hearing for the Restore NY grant.

Change Nesbitt Road to Nesbit LANE – Washington County Real Property Tax Services has requested that the Town Board pass a resolution to change Nesbitt *Road* to Nesbitt *Lane*. Before the Board passes such a resolution, they want to be sure any residents using Nesbitt *Road* for a mailing address are notified of the change. The Board will table the issue until next month.

NYS DEC Potential Purchase of two forest properties off Murray Hollow Road – The Town was notified by NYS Department of Environmental Conservation that the State is contemplating the purchase of two adjacent forest parcels (#242.-1-7 of 20.60 acres & #242.-1-8 of 249.10 acres) currently owned by Bly Hollow LLC. Prior to July 2017, the lands were owned by Cowee Forest Products. The larger of the two parcels abuts 535 acres of land owned by New York State. The Board didn't express any concerns about this potential transaction.

Consolidated Ag District #3 – Eight year Review – Ag District #3, which includes the western area of Jackson, is undergoing an eight-year review. The map will be on file and open for public inspection in the office of the County Clerk until December 1, 2017. Any municipality, State agency or landowner within or adjacent to the District may propose a modification of the district.

Bond Anticipation Note – Town Atty. D. Alan Wrigley has prepared the Bond Anticipation Note for the Town to renew the building repair loan of \$4,000 at a rate of 2.37% See attachment at end of these meeting minutes for **RESOLUTION NO. 88-17**.

Supervisor's Report -

- The 2018 County budget expects to be approved with an increase that falls under the tax cap.
- Four new supervisors were elected in the County during the election.

The Bond Anticipation Note - 2017 in the amount of FOUR THOUSAND DOLLARS (\$4000.00) shall be issued by the Town of Jackson in connection with repairs to the Town Highway Garage and the Town Hall in anticipation of the sale of Serial Bonds of the Town of Jackson in the amount of FOUR THOUSAND DOLLARS (\$4000.00). The receipt of the Supervisor of the Town Board of the Town of Jackson shall be full acquittance to the purchaser who shall not be obliged to see to the application of the purchase money. SECTION 6. The Bond Anticipation Note - 2017 is not issued in anticipation of Bonds for an assessable improvement.
