RESOLUTION #4-18

A motion by Councilman Rouse, seconded by Councilman Rea; Resolution passed 5-0, that the bank depository for the Supervisor, Justice and Town Clerk-Tax Collector accounts will be the Greenwich Branch of the Glens Falls National Bank & Trust.

RESOLUTION #5-18

A motion by Councilman Nolan, seconded by Councilman Rich; Resolution passed 5-0, giving the Highway Superintendent permission to spend up to \$3,000 maximum per month or \$1,000 per item without permission of the Town Board.

RESOLUTION #6-18

A motion by Councilman Rouse, seconded by Councilman Nolan; Resolution passed 5-0, giving the Supervisor permission to invest Town money in interest bearing accounts.

RESOLUTION #7-18

A motion by Councilman Rea, seconded by Councilwoman Rich; Resolution passed 5-0, selecting the *Eagle Press* as the official newspaper of the Town of Jackson.

RESOLUTION #8-18

A motion by Councilman Nolan, seconded by Councilman Rea; Resolution passed 5-0, **establishing mileage reimbursement at \$.32/mile.**

RESOLUTION #9-18

A motion by Councilman Nolan, seconded by Councilman Rouse; Resolution passed 5-0, giving the Town Supervisor permission to pay certain monthly bills in advance of the regular monthly meetings if the due date is too close to the meeting date, thus making the payment late (i.e. phone bill, internet, electric).

RESOLUTION #10-18

A motion by Councilman Nolan, seconded by Supervisor Skellie; Resolution passed 5-0, to appoint Councilwoman Rich as auditor of the 2017 Town Clerk-Tax Collector's accounts, and Councilmen Rea and Rouse as auditors of 2017 Justice accounts.

2019 Fire Contracts – Due to recent developments in the law and requirements for reporting to Towns, the Town's attorney has recommended certain additional provisions be inserted into the 2019 fire contracts. After some discussion, the Board suggested the Town send a letter with the attorney's recommendation to the four fire departments that serve Jackson and ask for their input.

Law to opt-out of certain energy systems – Supervisor Skellie shared a law that extends opting-out of tax exemptions for certain energy systems including farm waste energy, micro-hydroelectric energy, fuel cell electric generating equipment, micro-combined heat and power generating equipment, electric energy storage equipment and electric energy storage systems. The Board was asked to consider whether or not Jackson should pursue such a law.

Supervisor Report -

- The Center Falls Bridge will not be opening again for some time. While completing the repairs and painting, additional structural issues were identified. The estimated cost for the additional repairs is \$180,000. The County will learn soon if state aid will be available.
- Robert Henke will continue as Chairman of the Board of Supervisors. John LaPointe will serve as Vice-Chairman and Dan Shaw will serve as the County Budget Officer.

A motion by Councilman Nolan, seconded by Councilwoman Rich; Resolution passed 5-0, to approve payment of the following bills as audited on January 3, 2018, Abstract #1 and authorized the Supervisor to pay said bills from the respective funds:

RESOLUTION #12-18

A motion by Councilman Nolan, seconded by Councilman Rea; Resolution passed 4-0 with Supervisor Skellie abstaining, to re-certify the established standard six (6) hour workday for the position of Town Supervisor and that based on the three (3) month record of activities, a total of 1.93 days worked per month will be reported to NYS Retirement.

RESOLUTION #13-18

A motion by Councilman Nolan, seconded by Councilwoman Rich; Resolution passed 5-0, to re-certify the established standard eight (8) hour workday for the position of Chair of Assessors based on the three (3) month record of activities, a total of 4.52 days worked per month will be reported to NYS Retirement. Be it further resolved, to re-certify the standard eight (8) hour workday for the positions of Highway Superintendent and Town Clerk.
