• Earth Waste & Metal – A representative from Earth Waste & Metal requested a letter from the Town of Jackson that stated whether or not the company needed any additional permits to operate the transfer station in Jackson. The following statement was included in the letter that was signed by Supervisor Skellie:

Currently, no additional permits are required by the Town of Jackson. However, if Earth Waste and Metal decides to make any change to the use of the site, or expansion of the existing use, it will require site plan approval from the Town of Jackson. In addition, while it is not a local approval, the New York State Department of Environmental Conservation permit would probably have to be modified in the event of expansion or change in use of the site.

• <u>Peter Calabrese/Monolith Solar</u> – The Calabrese/Monolith application is still incomplete. Monolith expects to have the remaining items for the December 4, 2018 meeting. The Clerk will double check an email she wrote to Monolith about completing their application.
