8:04 PM PUBLIC HEARING - 2019 PRELIMINARY BUDGET

Supervisor Skellie opened the public hearing to welcome comments regarding the 2020 preliminary budget. There were no comments from the public. The hearing closed at 8:05 pm.

Fuel Bids – One fuel bid was received from Main-Care Energy along with a Non-Collusive Affidavit.

Highway – The Highway Department has been:

- Replacing culverts;
- Patching;
- Shimming on Content Farm Road; and
- Preparing for "winter" weather.

The Murray Hollow Road Bridge project has been completed. There may be a ribbon cutting ceremony if Senator Betty Little can attend.

The Village of Cambridge has a 1997-wheel loader with 8,500 hours for sale. After some discussion, the Board decided not to pursue purchasing it in hopes of finding a newer model. Supt. Carney also stated that the pick-up truck should be replaced soon. If the Town orders a truck now, it should be available by Spring 2020. Supt. Carney will check the prices of the new models.

Planning Board – No Planning Board report since the meeting is scheduled for November 12th

CARES – Mrs. Dunn shared the following:

- Medicare open enrollment continues until December 7, 2019. Contact the Office of the Aging and Disability Services for unbiased help navigating the Medicare programs.
- The Cambridge Library is getting positive recognition and feedback about the variety of programs they offer weekly for babies, preschoolers and elementary-age children.

OLD BUSINESS

Assessor position – Prior to the Town Board meeting, Jean McLenithan shared with Supervisor Skellie that she has reconsidered resigning from her assessor seat so the Town will not have to seek a certified assessor for 2020. She also asked the Town to pay for her and the two assessor-elects to attend training on December 6, 2019. The topic will be on property assessment re-evaluation which Jackson will be undergoing in 2020. The cost will be \$100 for Assessor McLenithan and \$150 each for the newly elected assessors.
