RESOLUTION #103-19

A motion by Councilman Rouse, seconded by Councilman Nolan; Resolution passed 4-0, **to approve the December 4, 2019 Town Board minutes as written.**

REPORTS

Highway – Supt. Carney calculated that 15 trips were made around Jackson by the plow trucks in December due to inclement weather.

The Towns of Argyle, Cambridge, Salem and White Creek have agreed to purchase a hot box for road patching at a total cost of \$38,483. Jackson has been invited to participate as well. The Town of Salem has space to store the equipment. An agreement will be drafted and the Towns will work with NYMIR to ensure the equipment has insurance coverage in each municipality. This project might fall under the *Shared Services* program and might cost less per town than initially determined.

CARES – At a recent CARES meeting, Mrs. Dunn received data from a 2019 assessment survey that was completed by the Office for the Aging and Disability Resource Center. Surveys were sent to 2,509 individuals over 60 years of age in Washington County. 28% of the surveys were completed and returned. While the survey provided a number of insights, one initiative that will be developed in 2020

as a result of the responses is caregiver training. A copy of the survey report is available at the Town Clerk's office.

Murray Hollow Road Bridge – Despite concerns with weather, the Murray Hollow Road Bridge Ribbon-Cutting Ceremony with Senator Betty Little went well on December 10th.
