TOWN OF JACKSON

LOCAL LAW #1 OF 2019

A LOCAL LAW to provide a partial exemption from real property taxes to qualified residents of the Town of Jackson who are sixty five years of age or older:

BE IT ENACTED by the Town Board of the Town of Jackson as follows:

Section 1. Legislative authority.

This article is enacted pursuant to the provisions of subdivision (1) Section 467 of the Real Property Tax Law of the State of New York.

Section 2. Exemption Amount

Pursuant to the provisions of subdivision (1) of Section 467 of the Real Property Tax Law of the State of New York, the sliding scale provision for real property tax exemptions for persons who are sixty-five years of age or over is henceforth set as follows:

<u>Annual Income</u>	<u>Percentage Assessment Valuation Exemption from Taxation</u>
0.00 to 18,000.00	50%
18,000.01-18,999.99	45%
19,000.00-19,999.99	40%
20,000.00-20,999.99	35%
21,000.00-21,899.99	30%
21,900.00-22,799.99	25%
22,800.00-23,699.99	20%
23,700.00-24,599.99	15%
24,600.00-25,499.99	10%
25,500.00-26,399.99	5%

Section 3: Applicable Law.

No exemption shall be allowed except in accordance with the provisions of Section 467 of the Real Property Tax Law for real property which qualifies by use and ownership upon application submitted to the matter provided by such section.

Section 4. Effective Date.

This local law shall take effect upon filing with the Secretary of State.


