8:04 PM PUBLIC HEARING – 2021 Preliminary Budget

Supervisor Skellie opened the public hearing to welcome comments regarding the 2021 Preliminary Budget. There were no comments from the public. The hearing closed at 8:05 pm.

8:05 PM OPEN REGULAR MEETING

Citizen Concerns/Comments – Bob Endee was present to discuss two topics with the Town Board.

First, he asked if the Board has discussed regulations specific to Air B&Bs. A property near his residence is operating as an Air B&B. Since the summer months, there have been occasions when the number of people at the property seem to exceed the property's capacity. Excessive noise has also been an issue including an evening when fireworks were ignited during dry weather. The Town Clerk said another resident near the same property visited the Town Clerk's office with similar concerns just prior to this meeting. She recommended that he contact Supervisor Skellie. Supervisor Skellie said Air B&Bs have been discussed at the County and are being identified frequently throughout the county.

The second item Mr. Endee shared was that multiple trash collection companies drive by his property each week. Each company's fees are increasing. He wondered if the Town might coordinate trash collection with the various companies whereby each would serve a different area of the town in hopes of reducing each company's travel costs thus reducing the fees to the residents.

REPORTS

Highway – Supt. Carney reported the department's activities in the month of October. He also shared that until he read the October 21st budget meeting minutes, he was under the assumption that he would be receiving the 5% increase in his salary requested for 2021. One board member concurred with his assumption, while the others said that salary increases would be set at 2% for those who requested an increase other than the Court and Planning Board Clerks. Once the salaries are posted in the legal notice, they cannot be increased, only decreased.

Planning Board – No Planning Board report; meeting is scheduled for November 10th

OLD BUSINESS

2021 Preliminary Budget – Before voting on the budget, Supervisor Skellie asked the other board members to concur that if the Justice transfers \$600 from the contractual line item to the Court Clerk's salary it is a permanent sacrifice of her contractual budget. The other board members agreed.

RESOLUTION #83-20

NEW BUSINESS

Cemetery at State Route 313 and Eagleville Road – Since May there has been interest in a cemetery located on the state land near the intersection of State Route 313 and Eagleville Road. Ben Thomas from NYS Department of Environmental Conservation is coordinating a spring clean-up of the site. He is seeking people to help and would also like to establish an official name for the cemetery.
