

**Town of Jackson Town Board Meeting
December 30, 2020**

The Town Board of the Town of Jackson met on December 30, 2020 at 1:00 pm at the Town Hall for the year-end meeting.

RESOLUTION #96-20

A motion by Councilman Nolan, seconded by Councilman Rea; Resolution passed 5-0, **to approve the December 2, 2020 Town Board minutes as written.**

REPORTS

Town Hall – The water at the Town Hall stopped working on December 28th. Leise Well Drilling completed repairs on December 30th and recommended a larger pump for the bathroom.

Highway – Supt. Carney calculated that 36-38” of snow fell on December 17th. Supervisor Skellie commended the highway staff on the great job they did managing the storm clean up stating that he received no phone calls from residents. Supt. Carney went on to share that there were very few flood issues the following week when the temperature reached 60 degrees. Paperwork has been submitted to County Emergency Services to help determine if the total cost of the December 17th storm (county-wide) will fall under the thresholds to receive FEMA recovery funds.

The Insurance Adjuster will be assessing the damages to the pick-up truck after the sander slid hard into the box/cab.

Main-Care Energy still has the state contract for diesel fuel. The town will continue to stay with Main-Care through 2021.

OLD BUSINESS

Emergency Preparedness Plan - Before the next Town Board meeting on January 6th, the Board members should review the Emergency Preparedness Plan. The Town Clerk stated that the Teamsters Union did not send a response about the plan after it was sent by email to Rocco Losavio on December

8, 2020. A follow-up email was sent on December 14, 2020 to confirm that it was received by Mr. Losavio. Again, no response. The Union was required to respond by December 23, 2020.

NEW BUSINESS

Governor Cuomo’s Executive Order 202.83 – On December 22, 2020, Governor Cuomo issued Executive Order 202.83 allowing municipalities to pass a resolution permitting assessors to grant income-based exemptions in 2021 without completing a renewal application to all property owners who received that exemption on the 2020 assessment roll. The Town Board will vote on this resolution at the at the next meeting.

RESOLUTION #98-20

A motion by Councilman Rea, seconded by Councilman Rouse; Resolution passed 5-0, **to approve the following budget amendment in the Highway fund:**

- **Reduce DA5112.2 Improvements (CHIPs) by \$7,767.21 so that it reflects the actual amount received for CHIPs. Add to \$7,767.21 to DA5110.4 General Repairs to account for the 2020 expense (24.5% reduction from the original CHIPs amount that was expected to be received).**
