Highway – Highway Supt. Carney was present to report on the Highway Dept.'s activity over the month of October. The Highway Dept. cleaned ditches on Reafield Farm Road. Equipment was put into for repairs. The '95 dump truck was getting rusty under the frame so the dept. had the frame sandblasted and plows and lights on the other dump trucks were fixed ahead of winter. Supt. Carney stated that the dept. is still down one man and hiring. The Board discussed ordering a new pickup off of a County piggyback bid if available, for roughly \$49,000.00-\$52,000.00.

NEW BUSINESS

Engineering Proposal for Town Hall Addition – Supervisor Skellie stated that the Town has received a proposal from consultant engineering firm Cottrell Associates to draw the plans for the storage space addition on Town Hall. With a billing rate of \$100 an hour the estimated cost of services is \$8,000.00. The funds for the engineered plans will come from existing ARPA grant money the Town has. The State requires stamped engineered plans from a NYS certified engineer before building on Town buildings can begin.
