REPORTS

Highway – Highway Supt. Carney was not present at the meeting but passed his report for November onto Supervisor Skellie:

- The Highway Dept. has been busy getting trucks ready for winter. The battery box on the '97 dump truck was rebuilt and the backhoe was serviced.
- The Dept. has started cleaning ditches on Murray Hollow Rd.
- Supt. Carney is still having difficulty finding a pickup available.
- The Dept. has had no luck finding someone to fill the vacant position, but they have received some help from former employee and Deputy Supt. Dick Bentley going into the winter season.

Planning Board – PB Chair Donahue was present to report on Tuesday night's meeting: [Christine Eldred entered at 8:15 pm during the reading of the Planning Board Report]

- The Planning Board has had discussions regarding a new solar application that has come forward for a 20 MW solar facility on Ackley Rd. The project applicants wish to separate the project into 4 separate 5 MW facilities so they can qualify for community distributed solar. A meeting between our Town Attorney and the Solar company's (Norbut Solar) Attorney was held at Town Hall to figure out logistics of the solar application and whether or not 4 separate applications, as well as a major subdivision application, is required. Supervisor Skellie, Town Clerk/Planning Board Clerk Dixson, Chair Donahue, PB member Mahoney and Norbut Solar Project Manager Victor Ciaccia were also in attendance. The application is for a 139-acre solar facility with 9-ft high panels. The application is halted until clarification from the County is received regarding the project's tax ID #'s that would impact subdivision and site plan requirements with the Town. Chair Donahue will keep the Town Board updated on this issue.
- The PB is considering moving forward with updating the bylaws or devising a renewable energies law. They will discuss this more in the new year.
